Industry Experience: I have worked in the Water and Stormwater fields for over 18 years, and have direct experience with local government water and stormwater utilities. My knowledge, interests and understanding range from stormwater management to water demand management; and cross connection control to inflow and infiltration issues and sanitary source control and wastewater treatment. Through both policy and infrastructure projects I work to address challenges our industry faces with infrastructure deficits, development pressures and climate change impacts.

Governance Experience: I have represented the BCWWA as a Board Director for the past three years. I am confident and comfortable in working with the BCWWA's governance model, and knowledgeable in the bylaws and processes.
